DESCRIPTION:

On July 14, 2014, Shareholders of Giant Interactive Group Inc. (GA) voted concerning the proposed merger with a wholly-owned subsidiary of Giant Investment Limited, a wholly-owned subsidiary of Giant Group Holdings Limited. The merger was approved and subsequently consummated on July 18, 2014. As a result, each existing GA American Depositary Share will be converted into the right to receive \$11.95 (\$12.00 - \$0.05 ADR cancellation fee) net cash per share, less withholdings if any.
