#### **ORBITAL SCIENCES CORPORATION - CONTRACT ADJUSTMENT**

### **DESCRIPTION:**

On January 27, 2015, Shareholders of Orbital Sciences Corporation (ORB) voted concerning the proposed merger with Alliant Techsystems Inc. (ATK) to form a new company named Orbital ATK, Inc. The merger was approved and subsequently consummated on February 9, 2015. As a result, each existing ORB Common Share will be converted into the right to receive 0.449 Orbital ATK, Inc. Common Shares. Cash will be paid in lieu of fractional Orbital ATK, Inc. shares. Immediately prior to the merger ATK will distribute all outstanding shares of Vista Outdoor common stock. The Merger Consideration to be paid in conjunction with the merger will be without the value of spun off Vista Outdoor common stock.

Orbital ATK, Inc. Common Shares will begin trading regular way on the New York Stock Exchange (NYSE) under the trading symbol "OA" on February 10, 2015.
