INTELIQUENT, INC. - CASH SETTLEMENT/ACCELERATION OF EXPIRATIONS

DESCRIPTION:

On January 17, 2017, Shareholders of Inteliquent, Inc. (IQNT) voted concerning the proposed merger with a wholly-owned subsidiary of Onvoy, LLC, an affiliate of GTCR, LLC. The merger was approved and subsequently consummated before the open on February 10, 2017. As a result, each existing IQNT Common Share will be converted into the right to receive \$23.00 net cash per share.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Inteliquent, Inc. options whose expiration dates are after 2-17-2017 will have their expiration dates advanced to 2-17-2017. Expiration dates occurring before 2-17-2017 (e.g., Flex options) will remain unchanged.

All Inteliquent, Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 2-17-2017

Existing American-style Inteliquent, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
