Section 1 Introduction

The purpose of this document is to detail the specifications of the BOX Options Market LLC (“BOX”) Automated Trade Reporting (“ATR”) data feed.

1.1 Objective

The main objective of this Guide is to provide Participants with the functionality required to interact with the BOX ATR data feed.

1.2 Scope

This document includes:

- ATR service description
- Message format and definitions
- Connection management and recovery management flow

1.4 Acronyms and Terms

Below is the definition of the acronyms and terms used throughout this document

ACRONYM AND TERM	DEFINITION
Clearing Participant	Clearing Participant means an Options Participant that is self-clearing or an Options Participant that clears BOX Transactions for other Options Participants of BOX
Give-Up Source Participant	Represents the executing Participant that Gives-Up the trade to another Participant.
Give-Up Receiving Participant	Represents the Participant that receives a trade (Give-Up) from another executing Participant.
ATR Server	The logical application that accepts connections from Participants to access the ATR feed.
Drop Copy Participant	A Participant that has been designated to receive a copy of specific non trade messages.

Section 2 Overview

2.1 ATR Description

The ATR consists of a private, real time feed containing Trades, Give-Ups, and Allocations executed on BOX. The private feature allows firms to receive only the following:

- Trades, Give-Ups, and Allocations in which they are the Participant who executed the trade (“Executing Participant”).
- Trades, Give-Ups, and Allocations in which they are the Clearing Participant.
- Give-Ups and Allocations in which they are the receiving Participant of a Give-Up.
- Give-Ups and Allocations in which they are designated as Drop-Copy Participants. Only one Drop-Copy Participant can be assigned per Allocation or Give-Up.

Note, the Trades, Give-Ups, and Allocations displayed in the ATR are only for activity on BOX. This can include the Trades done on BOX to offset Trades at an away exchange.

2.2 ATR Protocol

This document details the ATR Protocol Version **A2**.

For previous versions, please contact the MOC (refer to Section 1.3).

2.3 Communication

The ATR service is provided through a standard TCP/IP communication link. Once access is requested, a specific IP Port will be designated by BOX for the ATR. Each BOX Participant must maintain a configuration that identifies the ATR Server IP Address, IP Port Number, and the Participant

Username and Password for Login.

Note: ATR service set-up, IP addresses, and IP Port Number must be obtained from BOX.

Each Participant must ensure that it has a configuration file to control the time and destination of the connection and is responsible for initiating the connection to the ATR Server in a timely manner.

The ATR Server does not initiate any TCP/IP communications sessions with the ATR Participant. After the ATR Participant has made the connection to the ATR Server, it must transmit a login message to identify and authenticate itself.

3.5.1 Message Type 00 – Start Of Day (28 bytes)

Outbound Message : ATR Server to Participant

This message is used to advise the Participant about the initiation of application-to-application communication.

3.5.2 Message Type 01 – Start Of Day Acknowledgement (28 bytes)

Inbound Message : Participant to ATR Server

This message is **optional** and can be sent by the Participant as acknowledgement to the Start of Day (00) message to advise the ATR Server that it is ready to exchange messages.

3.5.3 Message Type 02 – Circuit Assurance (28 bytes)

Outbound Message : ATR Server to Participant

This message is sent by the ATR Server to verify that the Participant's application is running correctly. It is sent during the day at a fixed time interval (5 minutes). Note that the Circuit Assurance message may appear at any time during the session, even as part of the connection establishment handshake.

This message is a response to a Circuit Assurance message. It is **optional** and may be returned by the Participant in response to a Circuit Assurance message.

3.5.5 Message Type 04 – Restart Request (36 bytes)

Inbound Message : Participant to ATR Server

The Participant can use this message to restart their communications session. When the Participant sends a Restart Request, the body sequence number is used to request that the ATR Server begin its restart at this sequence number. Once the Restart Request is sent, the ATR Server will begin transmitting messages in the normal sequence.

3.5.7 Message Type 08 – End Of Trading (28 bytes)

Outbound Message : ATR Server to Participant

This message is sent by the ATR Server to advise Participants about the end of the trading day. After the end of trading message has been received, the Participant may request retransmission of any messages it needs prior to the eventual shutdown of the ATR service for the trading day.

An End-of-Text (ETX) ASCII character must follow each TCP/IP message sent or received by the ATR Server. This delimiter character is hexadecimal 03 (0x03) and must appear only at the end of the message content.

Section 4 Connection and Recovery Management

This section presents several examples of connection management flow.

4.1 Client Signon

After establishing a TCP/IP connection to the ATR Server, the Participant needs to login using a Client Signon (09) message.

If the Participant logs in with 3 consecutive unsuccessful attempts, the ATR Server will lock the Participant's account. Unlocking the account will require the MOC to reset the password and unlock the account.

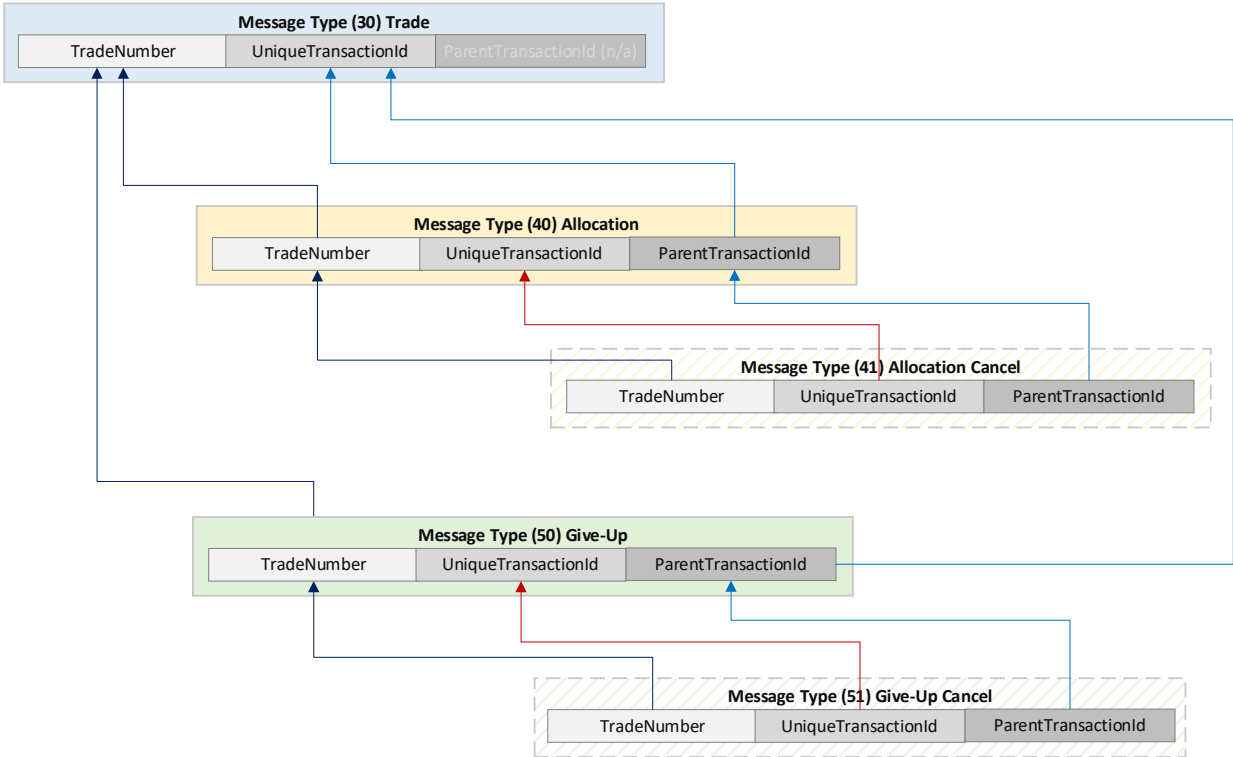

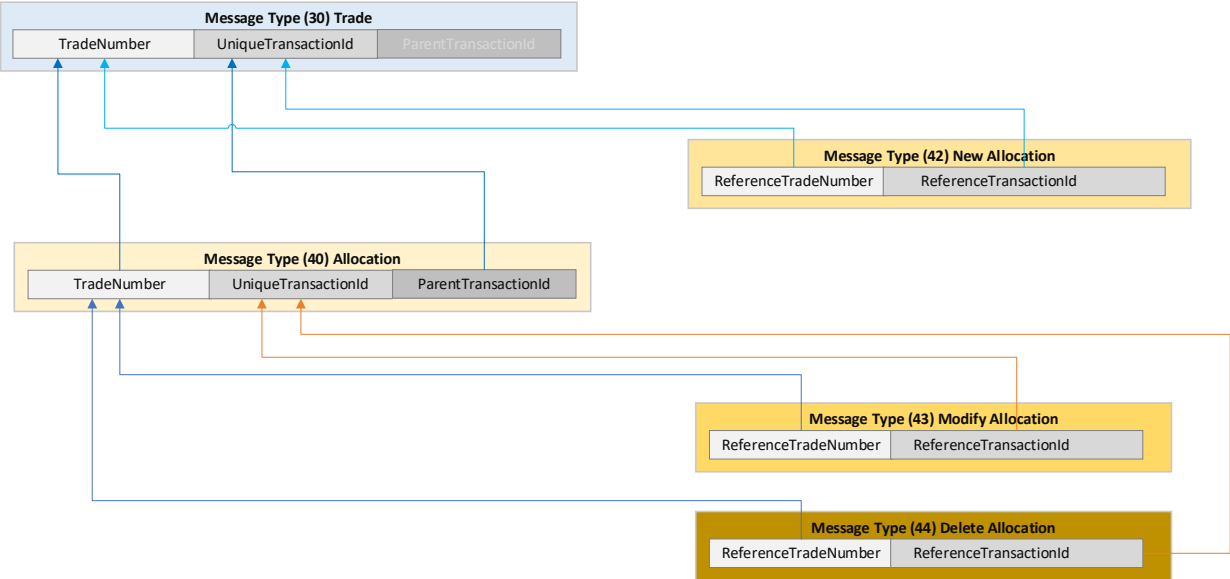
- A Trade and its child Allocation and Give-Up

The following diagram explains the relationship between:

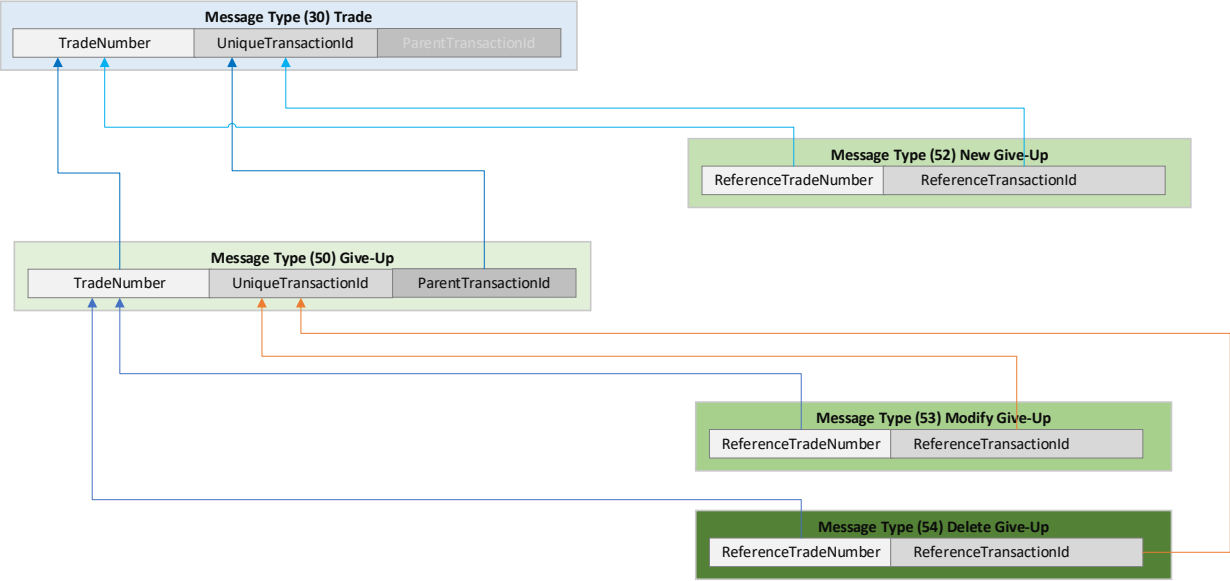
- New Allocation to create an Allocation from a Trade

6.2 Allocation Processing

The following describes the Allocation processing sequence:

1. Participant can send a New Allocation (42) message to create an Allocation under an existing trade or Give-Up.
2. Participant can delete an existing Allocation using the Delete Allocation (44) message.
3. Participant can modify an existing Allocation using the Modify Allocation (43) message. The system will cancel the previous Allocation and create the new one.

The following message sequence diagram shows the Allocation processing from the Buy-side Participant. The Sell-side Allocation sequence diagram is the same as the Buy-side.

6.2.1 New Allocation

Participants can create a New Allocation under an existing Trade for the whole or partial trade volume using the Message Type 42 – New Allocation with the following mandatory fields:

- ReferenceTransactionId must be set to the UniqueTransactionId of the Trade
- ReferenceTradeNumber must be set to the TradeNumber of the Trade

- Participant with access to BOX TMS (TradeManagement) GUI creates an Allocation using the Interface.
- Participant sends an Allocation file with Allocation instructions.
- Participant requests MOC to create an Allocation on their behalf.

In the above cases, the ATR Participants will receive Allocation (40) messages (Lines 3, 4, 5)

If the Allocation cannot be created, the submitting Participant (Executing Broker) will receive an Error Message with the appropriate Error Code and Text (reason of rejection)(Line 6).

6.2.2 Delete Allocation

An existing Allocation can be cancelled using the Delete Allocation (44) message. When deleting an Allocation using this method:

- ReferenceTransactionId must be set to the UniqueTransactionId of the previous Allocation which is to be deleted.
- ReferenceTradeNumber must be set to the TradeNumber of the Trade of the previous Allocation which is being deleted.

As a result of the successful deletion of an Allocation, an Allocation Cancel (41) message will be returned to the Participant which will have the same UniqueTransactionId and TradeNumber as the Allocation that is being deleted.

- Participant with access to BOX TMS (TradeManagement) GUI deletes an Allocation using the Interface.
- Participant sends an Allocation File with new Allocation Instructions, which replaces a previously created Allocation(s) which will be deleted.
- Participant requests MOC to delete an Allocation on their behalf.

In the above cases, the Participant will receive Allocation Cancel (41) messages (Lines 3, 4, 5).

If the Allocation cannot be deleted, then the submitting Participant will receive an Error Message with the appropriate Error Code and Text (reason of rejection)(Line 6).

6.2.3 Modify Allocation

An existing Allocation can be modified with new terms using the Modify Allocation (43) message with the following fields:

- ReferenceTransactionId must be set to the UniqueTransactionId of the previous Allocation which is being modified
- ReferenceTradeNumber must be set to the TradeNumber of the Trade of the previous Allocation which is being modified

The modification will be processed as follows:

- Cancel the original Allocation
- Create a new Allocation as replacement

An Allocation can be modified by other means than sending a Modify Allocation Message (43):

- Participant sends an Allocation File with existing Allocation but with modified terms (e.g quantity, sub-account, client account). The system will cancel the original Allocation and replace it with the new one.

Participants using the TMS GUI cannot modify an existing Allocation directly but must first cancel the original Allocation and create a new one.

In the above cases, the Participant will receive Allocation Cancel (41) messages (Line 3, 4, 5) followed by the new Allocation (40) messages (Lines 6, 7, 8)

If the Allocation cannot be modified, then the submitting Participant will receive an Error Message with the appropriate Error Code and Text (reason of rejection)(Line 9).

6.3 Give-Up Processing

The following sequences shows the Give-Up processing.

1. Participant can give-up a trade (for the full or partial quantity) using the New Give-Up (52) message.
2. Participant can cancel an existing Give-Up using the Delete Give-Up (54) message.
3. Participant can modify an existing Give-Up using the Modify Give-Up (53) message. The system will cancel the previous Give-Up and create the new one.

6.3.1 New Give-Up

Participants can create a new Give-Up under an existing Trade for the whole or partial quantity of the Trade using the Message Type 52 – New Give-Up with the following mandatory fields:

- ReferenceTransactionId must be set to the UniqueTransactionId of the Trade.
- ReferenceTradeNumber must be set to the TradeNumber of the Trade.
- Give-Up Firm refers to the receiving Firm of the Give-Up. A Give-Up Agreement **must** be in place with the receiving Firm, otherwise the New Give-Up message will be rejected.

- Participant requests MOC to create an Give-Up on their behalf.

In the above cases, the Participant will receive Give-Up (50) messages - Lines (3, 4, 5) for the Give-Up Source Firm and Lines (6, 7, 8) for the Give-Up Receiving Firm.

If the Give-Up cannot be created, then submitting Participant (Give-Up Source Firm) will receive an Error Message with the appropriate Error Code and Text (reason of rejection)(Line 9).

6.3.2 Delete Give-Up

A Give-Up can be cancelled using the Delete Give-Up (54) message. Only the Give-Up Source Firm can delete a Give-Up transaction. The receiving Give-Up Firm cannot delete a Give-Up but may give back the trade to the Give-Up Source Firm by a New Give-Up back to the Source Firm (provided a Give-Up Agreement exists).

To delete a Give-Up the following must be referenced:

- ReferenceTransactionId must be set to the UniqueTransactionId of the previous Give-Up which is being cancelled.
- ReferenceTradeNumber must be set to the TradeNumber of the Trade of the previous Give-Up which is being cancelled.

The Give-Up Cancel (51) message will have the same UniqueTransactionId and TradeNumber as the Give-Up which is being cancelled.

- ReferenceTransactionId must be set to the UniqueTransactionId of the previous Give-Up which is being modified.
- ReferenceTradeNumber must be set to the TradeNumber of the Trade of the previous Give-Up which is being modified.
- Give-Up Firm must be the same as the original Give-Up.

A Give-Up can be modified by other means than sending a Modify Give-Up (53) Message:

- Participant sends an Allocation File with existing Give-Up but with modified terms (e.g quantity, sub-account, client account). The system will cancel the original Give-Up and replace it with the new one.

Participants using the TMS GUI cannot modify an existing Give-Up directly but must first cancel the original Give-Up and create a new one.

In the above cases, the Source Give-Up and Receiving Give-Up firms will receive the corresponding Give-Up Cancel (51) messages followed by the New Give-Up (50) messages respectively.

If the Give-Up cannot be modified, then the submitting Participant (Give-Up Source Firm) will receive an Error Message with the Error Code and Text (Line 14).

Section 7 Password Encoding

This algorithm is to be used when encrypting the 'Password' field in the 'MessageType 09 – Client Signon'.

Step 1) Initialize values

Get the 'Password' value as assigned by the MOC at the initial creation of the 'Username'.

Take the value that will be passed in the field 'Time' in the 'MessageType '09' - Client Signon' message type which represents the time the message was sent.

Example:

```
Password = "PASSWORD"  
Time = "160803"
```

Step 2) Get the MD5 hash result

Concatenate the 'Time' and 'Password' values from step 1 and hash them using the MD5 algorithm.

The result should be a 32 hexadecimal character string.

Example:

```
HashToMD5("160803PASSWORD")  
Result: "9B9FD80B4A3FC5CC02DA4119B15F0C07"
```

Step 3) Encode to Base64 format

Take the last 8 bytes (rightmost) from the result of step 2 and encode it using the Base64 algorithm, with the following character set:

```
"ABCDEFGHIJKLMNOPQRSTUVWXYZabcdefghijklmnopqrstuvwxyz0123456789+/"
```

Example:

```
HexToBase64("02DA4119B15F0C07")  
Result = "AtpBGbFfDac="
```

Step 4) Set the Password and Time in the 'Client Signon' (09) message

Take the first 8 bytes of the result of step 3 to initialize the 'Password' field and the value use in step 1 for the 'Time' field.

Example:

```
Password = "AtpBGbFf"  
Time = "160803"
```
