DELL INC. - CASH SETTLEMENT AND CASH DISTRIBUTION/ACCELERATION OF EXPIRATIONS

DESCRIPTION:

On September 12, 2013, Shareholders of Dell Inc. (DELL) voted concerning the proposed merger with a wholly-owned subsidiary of Denali Holding Inc. The merger was approved and subsequently consummated on October 29, 2013. As a result, each existing DELL Common Share will be converted into the right to receive \$13.75 net cash per share plus a special dividend of \$0.13 per share.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Dell Inc. options whose expiration dates are after 11-16-2013 will have their expiration dates advanced to 11-16-2013. Expiration dates occurring before 11-16-2013 (e.g., Flex options) will remain unchanged.

All Dell Inc. options will utilize a \$.01 exercise threshold.

Existing Expiration: All months

New expiration date: 11-16-2013

Existing American-style Dell Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
