## HANWHA SOLARONE CO., LTD. - NAME/SYMBOL CHANGE

### DESCRIPTION:

The Options Clearing Corporation (OCC) has been advised that Hanwha SolarOne Co., Ltd. (HSOL) will change its name and trading symbol to Hanwha Q CELLS Co., Ltd. (HQCL). As a result, option symbol HSOL will also change to HQCL effective at the opening of business on February 9, 2015.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol HQCL commencing February 9, 2015.
