CREDIT SUISSE GROUP AG - CASH DISTRIBUTION IN LIEU OF RIGHTS

Ex - Distribution Date: 12/10/2015

DESCRIPTION:

Credit Suisse Group AG (CS) announced a distribution of Rights to holders of Credit Suisse Group AG Ordinary Shares. The Rights were not registered in the United States and will not be distributed to holders of CS American Depositary Shares (ADSs). In lieu of the Rights, Deutsche Bank Trust Company Americas, as the depository for CS, sold the rights in the home market and will distribute the proceeds of the sale to CS ADS Holders. The net distribution is \$0.4561 per ADS (gross rate of \$0.4761 - \$0.02 Depository Fee).

The ADS record date is December 14, 2015. The payable date is December 21, 2015. The New York Stock Exchange (NYSE) has set December 10, 2015, as the ex-distribution date.
