## XENOPORT, INC. - CASH SETTLEMENT/ACCELERATION OF EXPIRATIONS

### DESCRIPTION:

On July 1, 2016, AP Acquisition Sub, Inc., an indirect wholly owned subsidiary of Arbor Pharmaceuticals, Inc., completed its tender offer for XenoPort, Inc. (XNPT) Common Shares. The subsequent merger was completed on July 5, 2016. As a result, each existing XNPT Common Share will be converted into the right to receive \$7.03 net cash per share.

#### ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of XenoPort, Inc. options whose expiration dates are after 7-15-2016 will have their expiration dates advanced to 7-15-2016. Expiration dates occurring before 7-15-2016 (e.g., Flex options) will remain unchanged.

All XenoPort, Inc. options will utilize a \$.01 exercise threshold.

Existing Expiration: All months

New expiration date: 7-15-2016

Existing American-style XenoPort, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
