MENTOR GRAPHICS CORPORATION & CASH SETTLEMENT/ACCELERATION OF EXPIRATIONS

DESCRIPTION:

On February 2, 2017, Shareholders of Mentor Graphics Corporation (MENT) voted concerning the proposed merger with Meadowlark Subsidiary Corporation, a wholly-owned subsidiary of Seimens Industry, Inc. The merger was approved and subsequently consummated on March 30, 2017. As a result, each existing MENT Common Share will be converted into the right to receive \$37.25 net cash per share.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Mentor Graphics Corporation options whose expiration dates are after 4-21-2017 will have their expiration dates advanced to 4-21-2017. Expiration dates occurring before 4-21-2017 (e.g., Flex options) will remain unchanged.
