

**Diana Shipping Inc. - Distribution****DESCRIPTION:**

Diana Shipping Inc. (DSX) has announced a distribution of (New) OceanPal Inc. (OP) Ordinary Share. The distribution ratio is 0.10 of an OP share for each DSX share held. The record date is November 3, 2021; the payable date is November 9, 2021. The NYSE has set November 10, 2021, as the ex-distribution date for this distribution.

OceanPal Inc. Common Shares are expected to be listed on Nasdaq under the ticker symbol "OP". It is not yet known if there will be when issued trading.
