### DESCRIPTION:

UpHealth, Inc. (UPH) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each UPH Common Share will be converted into the right to receive 0.10 (New) UpHealth, Inc. Common Shares. The reverse stock split will become effective before the market open on December 9, 2022.

### Contract Adjustments:

Pursuant to the By-Laws of the Options Clearing Corporation ("OCC"), the below options will be adjusted as follows.
