DESCRIPTION:

Camber Energy, Inc. (CEI) has announced a 1-for-50 reverse stock split. As a result of the reverse stock split, each CEI Common Share will be converted into the right to receive 0.02 (New) Camber Energy, Inc. Common Shares. The reverse stock split will become effective before the market open on December 21, 2022.
