DESCRIPTION:

Future FinTech Group Inc. (FTFT) has announced a 1-for-5 reverse stock split. As a result of the reverse stock split, each FTFT Common Share will be converted into the right to receive 0.2 (New) Future FinTech Group Inc. Common Shares. The reverse stock split will become effective before the market open on February 1, 2023.
