SUBJECT: Bid-Ask Differentials for Various Symbols through June 19, 2021
DATE: March 17, 2021

BOX Exchange LLC ("BOX"), by its authority under the provisions of BOX Rule 8040, has temporarily established modified bid-ask differentials for the following option classes. The below Market Maker quote width requirements will be effective through **June 19, 2021** unless withdrawn by BOX prior to that time.
